






# Location Caldwell & Redding Roads 1.6 miles north of Brookhaven Station along Gold Line

MARTA for 305.73 square feet and temporary construction easement in order to support construction of

the Intersection Improvements; and

WHEREAS, the Board has determined that a non-exclusive permanent easement on Parcel

C3232H will not interfere with rapid transit system construction, operation or maintenance; and

WHEREAS, section 8(r) of the MARTA Act of 1965 as amended permits MARTA to dispose of

property to municipalities and government agencies without seeking competitive bids, provided that the

Authority receives consideration at least equal in value to the disposed interest, as established by

independent appraisal; and

WHEREAS, Parcel C3232H has been appraised for a total fair market value of the permanent

easement, temporary construction easement and site improvements in the amount of \$16,900.00; and

RESOLVED THEREFORE, by the Board of Directors of the Metropolitan Atlanta Rapid Transit

Authority that the General Manager/CEO or his delegate is hereby authorized to do all acts, perform all

things, and execute on behalf of the Authority all instruments of conveyance, other instruments and

#### **SCOPE**

- Subsurface exploration and testing
- Site reconnaissance and geologic mapping
- Geotechnical drilling/Groundwater monitoring/Laboratory testing
- Pre-construction and post-construction structural condition surveys
- Blast and vibration monitoring
- Slope stability/Settlement analysis

#### **STATUS**

- January 22, 2024, the Planning & Capital Programs Committee was briefed on the plan to conduct a qualifications-based selection process to solicit firms to provide Geotechnical Engineering Consultant Services
- In June 2024, Qualification Statements were received from eleven Geotechnical firms which the Source Evaluation Committee (SEC) members independently reviewed and scored to determine a shortlist of four firms.
- August 13, 2024, oral interviews were conducted with the four shortlisted firms and selected most qualified proponent.



#### RECOMMENDATION

 The SEC recommends the Approval of a Resolution authorizing the General Manager/CEO or his delegate to enter into a Contract for the Procurement of Geotechnical Engineering Consultant Services, AE50471 with ECS Southeast, LLC.

- Periodic construction inspection and observation

#### **STATUS**

- January 22, 2024, the Planning & Capital Programs Committee was briefed on the plan to conduct a qualifications-based selection process to solicit firms to provide Materials Testing On-call Consultant Services
- In July 2024, Qualification Statements were received from six Material Testing firms which the Source Evaluation Committee (SEC) members independently reviewed and scored.
- August 16, 2024, the SEC met to review the score ranking matrix prepared by Contracts & Procurement and discuss the rankings. The SEC concurred and selected most qualified proponent.



#### RECOMMENDATION

The SEC recommends the Approval of a Resolution authorizing the General Manager/CEO or his delegate to enter into a Contract for the Procurement of Material Testing Consultant Services, AE50472 with Terracon Consultants, Inc. **DBE Subconsultants**



## **Train Control Background**


- MARTA heavy rail signaling uses Automatic Train Control (ATC) technology
  - Knorr (formerly Alstom) and Union Switch and Signal (US&S) technology
  - GOA 2 (\*Grade of Automation Level 2)
  - Proven but antiquated
- Train control hardware based on track circuits
- MARTA operates a fixed block signaling system
- Heavily dependent on hardware, field equipment and maintenance
- Train Control and SCADA Upgrade Project addressed control and communication equipment






#### **CBTC Introduction**

- MARTA requires extensive upgrades and modernization of the "vital" train control system hardware, software, control and safety systems
- Signaling is one of the five critical elements for safe and reliable rail operations







## **CBTC** Project Overview


- Initial Program Development July 2022 through March 2023
- Request to Solicit Proposals March 30, 2023 PCP Committee & April 13, 2023 BOD Meeting
- RFP Development May through September 2023
- Notice of the Request for Proposals Advertised September 5, 2023
- Proposal deadline January 8, 2024
- Technical Evaluation Committee reviewed proposals and presented to SEC
- Source Evaluation Committee (SEC) reviewed and evaluated proposals
- SEC selected Stadler US, Inc.





#### **Stadler CBTC Solution**

- Fully integrated CBTC train control and signaling system using NOVA Pro

## **Financing and Budget**


- Exploring creative financing via internal mechanisms
- MARTA will seek federal grant opportunities
- Included in the current CIP budget
- Process for 10-year Capital Improvement Program budget
  - Anticipated cash flows through 10-year CIP model
  - Development of timeline on needed cashflows to evaluate funding availability
  - Apply any debt requirements needed to finance the capital plan
  - Goal is presenting a balanced plan
  - Reallocation of resources based on project prioritization
- Possible bridge financing (TIFIA loan)
